

Terms & Conditions ("T & C") of NRI Achievers Awards (NRIAA)

The NRIAA is administered by the team at Film & TV Trade Preview (FTTP), who are responsible for both the nomination process and the selection of the ultimate winners. It's important to note that the terms and conditions associated with these awards may be subject to change or modification in the future. Participants and eventual awardees are expected to comply with and be legally bound by these terms and conditions.

Categories:

Entrepreneurs

The "Entrepreneur" category of the NRIAA belongs to any individual or organization those have setup their business in any country other than India. The existence of the respective business should be minimum of 2 years as on January 1, 2024.

Professionals

The "Professional" category of the NRIAA belongs to any individual who is working in any organization as a trained professional. The qualifier of this category can be any MBA, Doctor, Engineer, Advocate, Chartered Accountant, Teacher, Fashion Designer and Jewellery Designer etc. The experience of the professionals should be minimum of 2 years as on January 1, 2024. Participant (s) should have submitted the documents to prove the category's qualification poof.

Art & Entertainment

The "Art & Entertainment" category of the NRIAA belongs to those who have proved their courage in the performing and non-performing arts like Any Dance form, Acting, Stand up-comedy, Music, Art etc.

Academics

The "Academics" category of the NRIAA belongs to the students' Academic Achievement for the age group between 11- 18 years. These students deserve recognition for academic endeavours. Parents of these students should be Indian originated and staying abroad as written in terms and conditions.

The Award categories may be changed/modified/split/merged/increased or cancelled by the Jury/Award Management based on the number and quality of entries received in each category. Awards management /Jury may minimize or maximize the numbers of awards of the same category to maintain the agenda of maximum beneficiaries. Online submission by any Participant (s) doesn't confirm any nomination. The Awards management will not entertain any queries in this regard.

Eligibilities

- a) Participant (s) should be a Non-Resident Indian (An individual who is residing abroad for more than 182 days) during the course of the preceding financial year, for the purpose of employment, study, business or for any other profession.
- b) Participant (s) can also be a PIO (Person of Indian Origin)/ An individual is a citizen of a foreign country if he/she at any time held an Indian passport; OR
 - I. He/she or either of his/ her parents or either any of his/ her grandparents was a citizen of India; OR
 - II. He/she is a spouse (not being a citizen of Bangladesh or Pakistan) of an Indian citizen or (a) or (b) above.
 - III. Any individual participating in the Awards should be of Indian origin residing in the country from which he/she are applying.
 - IV. Participant (s)s must upload a scan copy of all pages of his/her Indian Passport. This is a mandatory document without which the Participant (s) will be disqualified. Participant (s) should have a valid/expired Indian passport to prove Indian originate.
 - V. Participant (s) should be residing in the country applied for a period of minimum 2 years as on January 1, 2024.

- VI. For the Entrepreneur/Brand category, the organisation should have completed more than 2 years of operation as on January 1, 2024. It is mandatory for them to submit the organisation's registration certificate.
- VII. For Professional category the Participant (s) needs to submit a signed declaration form printed on organisation's letter head where the Participant (s) is currently working stating the duration of 2 year of employment as on January 1, 2024. The declaration form needs to be signed by the signing authority of the organisation (MD, CEO, COO, Chairman etc.). If Participant (s) as newly joined, he/she should produce the same from previous employer.
- VIII. Participant (s)s for the Academics category should be currently a student in any institute (Part-time, Full time, Distance course). The Participant (s) needs to submit their current institutes ID card/ Bona fide certificate/Letter from the principal stating that they are currently studying in the institute along with the term duration. If the Participant (s) is of age lesser than 18 years (for Academics category only), then consent letter in the format defined by Awards Management need to be submitted duly signed by the Parent or the Guardian of the Participant (s). The scan copy of the consent form needs to be uploaded while submitting the application form.
- IX. For Art & Entertainment category the Participant (s) needs to submit their performance video in a form of link on the website.
- X. The final eligibility of the Participant (s) will be subject to the discretion and approval of Jury.
- XI. Participation in the Awards in any manner will be construed as an acceptance to the Terms and conditions stated herein.

Terms Conditions:

- 1) The Participant (s) hereby irrevocably authorizes the Awards Management to use the data gathered during and/or the Awards in respect of the Participant (s). This shall be the property of FTTP shall be entitled to use the same in its communications including marketing promotions and advertisements along with/without FTTP's brand.
- 2) Awards Management shall not be liable in any manner for any mishap, accident, injury or damages etc. of whatsoever nature, caused to the Participant (s) during the Awards. Further, Awards Management shall not be liable in any manner for any loss, damage, theft, or any other mishap caused during the Awards.
- 3) The Participant (s) agrees that personal data, information and any confidential information provided by the Participant (s) submitted with the entry ("Personal Data"), shall be processed, stored and/or otherwise used by FTTP for the purpose of conducting and administering this Event. The Participant (s) further acknowledges that by participating in this event, the Personal Data will be transmitted, processed, disclosed and shall be used by FTTP and/or published/distributed to its partners, sponsors, associates for, including but not limited to, communication of campaigns, promotional activities, future business initiatives, associates brands and products, in perpetuity. The Participant (s) further agrees to give full unconditional consent for FTTP to share any information provided by the Participant (s) with agencies working with them with regards to the program, its recording and broadcasting and related activities including agencies involved with FTTP.
- 4) If at any time, including after the conclusion of any of the Award ceremonies, any information provided by any Participant (s), is found to be incorrect in any manner, then the Participant (s) will be liable to be disqualified and / or return the Award and the monetary emoluments provided to the Participant (s) under this Award, if any. Awards Management may also take penal action against the Participant (s) for providing false information to participate in the Awards.
- 5) Determination of whether information provided as fair and accurate rests with the Jury and Awards Management.
- 6) Participant (s) agrees that the Participant (s) is legally capable of entering and, if selected, participating in the Awards and agree to the "T & C" and that Participant (s) is competent (i.e. Participant (s) are of legal age and mental capacity) and eligible to enter into this legally binding agreement on Participant (s).

- 7) Participant (s) understands and agrees that merely participating in these Awards does not entitle the Participant (s) to a prize or to any other form of consideration.
- 8) Participant (s) warrants and represents to the Awards Management that all information including any communications, software, photos, text, video, graphics, music, sounds, images and other material submitted or recorded in any manner by the Participant (s) or the partners of Awards Management including Awards Management for consideration for the Awards are solely owned by the Awards Management and do not infringe upon any other individual or organizational rights (including, without limitation, intellectual property rights). Participant (s) shall be completely responsible for handling any infringement or alleged infringement and shall indemnify the FFTP entities (in India or abroad), and the Awards Management from any claims, costs or damages from infringement or alleged infringement of the logo or trademark or the defense of a claim or any costs payable thereof.
- 9) Participant (s) must enter the Awards at their own will and the Awards Management are not in any way obligated or liable for any loss or costs that the Participant (s) may suffer or incur and nothing is payable to the Participant (s) for participating in the Awards or any event prior to or following the Awards.

- 11) The Awards Management reserves the right to, at its discretion, withdraw or amend or add to the T&C of the Awards at any time, with prospective or retrospective effect, and does not take responsibility for any loss or damage that any individual or organization may suffer as a result of participating or attempting to participate in the Awards, the Awards being withdrawn or its Terms amended.
- 12) The Participant (s) indemnify FFTP, its employees, officers, contractors, partner or other persons used by them in relation to this Awards and hold them harmless against any loss, claim, demands, costs, damages, judgments, expenses or liability (including legal costs) arising out of or in connection with any or all claims, that may be brought against the Awards Management by any third party in connection with the Participant (s) participation in or winning the Awards, which is inconsistent with any of the warranties and representations made by the Participant (s), or due to breach of these Terms and shall reimburse FFTP for any loss, costs, expense, or damage to which said indemnity applies. FFTP shall give the Participant (s) prompt written notice of any claim or actions covered by this indemnity, and the Participant (s) shall have the right, at its own expense, to participate in any such action.
- 13) Decision of Awards Management on all matters is final and binding on all Participant (s) and no correspondence will be entertained for the same.
- 14) In the event these Terms do not cover any question or complaint in relation to the Awards, the same will be concluded on by the Awards Management (for all other issues) or an independent body or legal team as appointed by the Awards Management and deemed necessary.
- 15) The Participant (s) agrees to give full consent unconditionally for FFTP to share any information provided by the Participant (s) with agencies working with them with regards to the program, its recording and broadcasting and related activities including agencies involved with FFTP.
- 16) The decision of FFTP in relation to the interpretation of any of these "T & C" shall be final and binding on the Participant (s).

- 24) Last date for submitting the nomination is February 1, 2024.
- 25) A fee for registration, processing and marketing will be applicable to all the final winners. Shortlisted participants will receive a detailed email about the fee and deliverables. Once we receive a confirmation email from the participant (s) for the same, they will be selected as the final winners. However, FTTP has the right to waive or reduce the fees amount for the honorary or any other candidates.
- 26) Receipt of application forms after last date of receipt specified may be permitted only at the discretion of the Awards Management.
- 27) Disqualification of entries is at the sole discretion of the Jury, on a case-by-case basis.
- 28) If at any time, during the Awards process or post the Awards, any information provided by any Participant (s) is found to be incorrect in any manner, then the Participant (s) will be disqualified from the Awards.

All disputes relating to or arising out of the Awards shall be subject to the laws of India, and shall be subject to the exclusive jurisdiction of the courts of competent jurisdiction at Mumbai, India.
