

Terms & Conditions (“T&C”)

NRI Achievers Awards

The NRI Achievers Awards is managed by Eventinity Ventures Private Limited (“EVPL”). EVPL personnel are responsible for managing the Awards, including the nomination process and final selection of winners. These Terms & Conditions may be amended, modified, or updated at any time without prior notice. By participating in the Awards, all participants (“Participants”) agree to be bound by these Terms & Conditions.

1. Award Categories

1.1 Entrepreneurs

This category applies to individuals or organizations that have established a business in any country outside India. The business must have been in continuous operation for a minimum of **two (2) years as on April 1, 2026**.

1.2 Professionals

This category applies to individuals working as trained professionals, including but not limited to MBA graduates, Doctors, Engineers, Advocates, Chartered Accountants, Teachers, Fashion Designers, Jewellery Designers, etc.

Applicants must have a minimum of **two (2) years of professional experience as on April 1, 2026** and must submit documentary proof of qualifications and experience.

1.3 Art & Entertainment

This category applies to individuals who have demonstrated excellence in performing or non-performing arts such as dance, acting, stand-up comedy, music, visual arts, and similar creative fields.

1.4 Academics

This category applies to students aged **11–18 years** who have demonstrated academic excellence. Parents of such students must be of Indian origin and residing abroad.

The Award categories may be modified, merged, split, increased, reduced, or cancelled at the discretion of the Jury and Awards Management based on the number and quality of entries received. Online submission does not guarantee nomination or selection. No correspondence in this regard shall be entertained.

2. Eligibility Criteria

1. Participants must be **Non-Resident Indians (NRI)**, defined as individuals residing outside India for more than 182 days during the preceding financial year for employment, business, study, or any lawful purpose;
OR
Persons of Indian Origin (PIO), defined as individuals who:
 - Have held an Indian passport at any time; or
 - Whose parents or grandparents were citizens of India; or
 - Are spouses (not citizens of Bangladesh or Pakistan) of Indian citizens or persons qualifying under the above criteria.
2. Participants must be of Indian origin and residing in the country from which they apply.
3. Participants must upload scanned copies of all pages of their Indian passport (valid or expired). Failure to upload this document will result in disqualification.
4. Participants must have resided in the applied country for a minimum of **two (2) years as on April 1, 2026**.
5. **Entrepreneur Category:**
The organization must have completed a minimum of two (2) years of operation as on April 1, 2026. Submission of the organization's registration certificate is mandatory.
6. **Professional Category:**
Participants must submit a signed declaration on the employer's letterhead confirming at least two (2) years of employment as on April 1, 2026. The declaration must be signed by an authorized signatory (MD, CEO, COO, Chairman, etc.). If recently joined, documentation from the previous employer must be provided.
7. **Academics Category:**
Participants must currently be enrolled in an educational institution (full-time, part-time, or distance learning). Proof such as a valid ID card, bonafide certificate, or letter from the institution must be submitted.
For Participants under 18 years of age, a parental or guardian consent form (as prescribed by Awards Management) must be uploaded.
8. **Art & Entertainment Category:**
Participants must submit a performance video link as part of their application.
9. Final eligibility and acceptance are subject solely to the discretion of the Jury and Awards Management.

Participation in any manner constitutes acceptance of these Terms & Conditions.

3. General Terms & Conditions

1. Participants irrevocably authorize EVPL to use any data, photographs, videos, recordings, or materials collected during or in connection with the Awards for marketing, promotional, and communication purposes, with or without EVPL branding.
